In announcing the award, CEO of SuperRatings, Nathan MacPhee, said "Sunsuper received the award based on solid investment performance and competitive fees as well as being market leaders in relation to engagement, advice and communication for and with members." It was a hotly contested competition with a number of funds in the running, but according to MacPhee, "whilst there are a number of excellent superannuation funds, Sunsuper continues to be a leading provider of end-to-end retirement solutions with an outstanding accumulation product, near seamless transition to retirement service, coupled with a well-tailored pension offering."

With over 1 million members and in excess of \$20 billion in assets, Sunsuper accounts for almost 1 in 10 working Australians and in recent years has seen its footprint move beyond its traditional Queensland base to the rest of the eastern seaboard.

The Fund of the Year is traditionally drawn from the finalists of both the SuperRatings' "Super of the Year" which is effectively the pre-retirement part of funds, and the SuperRatings' "Pension of the Year" which as implied, is the post-retirement part of funds. With Australians now being forced to rely on their super funds right through their working life until well into their retirement, the Fund of the Year seeks to recognise the best "end to end" service in the industry.

SuperRatings reviewed over 300 pre-retirement products and 150 Pension products to determine the winner. From each of these categories a short list of ten was determined. These finalists are shown below:
